**RESOLUTION CANVASSING RETURNS
OF VOTES OF SCHOOL DISTRICT GENERAL ELECTION**

BE IT RESOLVED by the School Board of Independent School District No. 877,
as follows:

- 1. It is hereby found, determined and declared that the General Election of the voters of this School District held on November 5, 2024, was in all respects duly and legally called and held.
- 2. As specified in the attached Abstract and Return of Votes Cast, at said election a total of 47,267 votes were cast at said election on the election of four school board members for four-year term vacancies on the board caused by expiration of term on January 1 next following the general election; as follows:
