1. Presentation: Buffalo High School BHS Principal Mark Mischke

BHS mission statement looked at continuously. Learning Recovery program keeping students on track before they fail a class. Works with the teacher of that class. Community Partnerships includes Industry Council and Career Fair for students to discover what they might be interested in. Advisory time helps build relationships. Same four students meet 25 mintues, twice a week for four years. B1 leaders are juniors and seniors who meet with 9th graders during the advisory sessions. Relationships that are built carry through in everyday experiences.

Site Improvement Plans and Reflection Principals Pam Miller, Director of Teaching and Learning Mat Nelson, DES Principal presented the elementary building plans which are similar across the district. Mark Mischke, BHS Principal presented for the secondary buildings. Goals carry through from Kindergarten to graduation.

 Food service fund is in good shape as we continue to offer free meals to students.
 Budget allows for purchase of equipment. Community Service fund is also in in good shape and coming in close to budget. General fund revenues and expenditures have both increased and revenue is higher than expenditures.
- 4. Quarterly Cash and Investment Report October 31, 2024 Ryan Tangen, Director of Finance and Operations Cash and investment balance as of October 31st is \$26,423,441. OPEB fund continues to serve the district well.
- 5. 2024 Payable 2025 Final Property Tax Levy Certification Ryan Tangen, Director of Finance and Operations

Truth in Taxation hearing will be held at the December school board meeting. Property Tax Levy amount is the same as reported in September. Property tax notices will be mailed this month. A \$300,000 home will now see an increase of \$5 from last year. This is due to an increase of 1.26% in referendum market value and a decrease of .12% net tax capicity values.

Although enrollment is decreasing, the total ADM count was 50 more than budgeted.
